



## **Public Encampment Certification Checklist**

This checklist is meant to aid Florida counties in submitting a complete public encampment certification request for property which a county has designated as a public camping or sleeping site per section 125.0231, Florida Statutes.

### **DESIGNATED PROPERTY CERTIFICATION REQUEST**

This section covers required supporting documentation for a request for certification of a designated public camping or sleeping property, with or without an accompanying finding financial hardship exemption request.

To receive a certification, counties must certify and submit documentation proving:

1. Proof of county or municipal ownership of the property.

2. A majority vote of the county's governing body has designated this property for public camping or sleeping per section 125.0231, Florida Statutes.
