Programs at **Hernandez House** and **Lakeview Place** help people with severe and persistent mental illnesses or who are dually diagnosed with a mental health issue and substance use disorder. The residential counselor and certified behavioral health technician work with residents to help them learn and improve their independent living skills and life skills so that they may eventually function well in the community. Often, residents come to this transitional level once they achieve stability at the **Lakeview Lodges** and once they have committed to making community living their goal.

Lakeview Villa is the least restrictive residential program on the Lakeview Center campus. The 20-unit apartment building is a place where residents can maintain their own households yet have the support they need to remain stable. In this program we help adults who are experiencing persistent mental illness or have been dually diagnosed with mental illness and substance abuse disorders. A certified behavioral health technician and a specialized case manager is assigned to residents of **Lakeview Villas**.

The LIHTC gives incentives to builders and developers to provide affordable housing to low-income persons. The maximum rent charged is based on the AMI, Area Median Income. This apartment may still be unaffordable to low-income persons due to this AMI. Check the current rental rates to see if this is affordable to you. There are 44 low-income apartments located here.

Oakwood Apartments is a Low-Income Housing Tax Credit apartment located in Milton, FL. Owners or developers of projects receiving the LIHTC agree to meet an income test for tenants and a gross rent test. There are three ways to meet the income test:

- 1. At least 20 percent of the project's units are occupied by tenants with an income of 50 percent or less of area median income adjusted for family size (AMI).
- 2. At least 40 percent of the units are occupied by tenants with an income of 60 percent or less of AMI.
- 3. At least 40 percent of the units are occupied by tenants with income averaging no more than 60 percent of AMI, and no units are occupied by tenants with income greater than 80 percent of AMI.
